In addition, there is also an electronic version of the Secretary Book which works in MS Excel. Please check your club listings in the ACS magazine and on the ACS website to confirm all information accuracy.

The Specialty show shall only be awarded to a current A.C.S. affiliated club. Clubs wishing to apply for hosting the Specialty show should do so at least one year in advance. We request that your club try to hold the show in a hotel with all functions held there and an awards banquet or dinner at a restaurant at a reasonable cost. The host club must agree to provide a meeting room for the ACS general meeting, board and judges panel meetings, a table for an ACS display of a raffle in the cockatiel division area, and a catalog listing of all ACS Show Awards. The cockatiel division shall observe all ACS show classifications. ACS show cages required for advanced division only. The host club must provide staging and benching area for advanced and novice divisions. Each show bench must be a minimum of 16 feet in length for judging with an additional 6-8 foot table at the right end of the Advanced Show bench for staging space, and lighting. In return, ACS will provide an ACS Panel Judge for advanced and novice divisions, all expenses paid. ACS will provide Cockatiel Division show awards as permitted by funding. The host club will receive all entry fees.
